WSA Canoe/Kayak Associate Access and Responsibilities

Access:

- 1. Associates will be given associate cards that will provide the front gate access code.
- 2. Associates will be given a key to the clubhouse.
- 3. Associates will have full access to WSA clubhouse, patios and grill.
- 4. Associates are limited in that they are non-voting. The mission of the WSA is for the perpetuation of sailing and sailboat racing. Voting rights in the WSA must be limited to those members who participate in the mission of the WSA.
- 5. Paddles and life jackets may not be stored in WSA storage areas.
- 6. Boat ramps must not be obstructed. Shoreline space is limited. Kayaks and Canoes must use prescribed launching areas and be properly stored in assigned rack spaces when not in use.
- 7. As canoe/kayak space is limited each associate is limited to two spaces. The first space is covered in the Registration Fee. An additional boat is \$15.00.
- 8. Large family gatherings require permission from the Grounds Chairman.
- 9. Canoe/Kayak length must be limited to 18 feet in length.
- 10. Associates must remove canoe/kayaks by November 30th.

- 2. All Associates must abide by the rules & bylaws of WSA.
